## **GUEST PASS REQUEST AND CONTRACT**

- attach a copy of a photo ID
- not have been expelled from Bishop Dwenger High School
- return the request when purchasing your dance tickets no later than the Thursday preceding the dance. LATE CONTRACTS WILL NOT BE ACCEPTED. Guest tickets cannot be purchased without a completed request.

# DANCE DRESS CODE AND POLICIES

The goal of Bishop Dwenger High School is to ensure a safe, healthy and moral environment that honors the values of our Catholic school. These policies emerge from our shared mission in promoting the Catholic Christian values that recognize the dignity and self-worth of all people. Within this setting, dances are viewed as an opportunity for students to socialize in a supervised and safe environment. Student behavior and manner of dress should reflect this guiding principle. The following has been approved by the administration and chaplains of our school.

### **DRESS CODE**

#### **GIRLS**

Dresses should be formal or semi-formal, short or long.

Dresses should be appropriately fitting and modest. They should not be too tight or cling to the body.

Dresses should not "ride up" as the student dances.

Hemlines for dresses must be no shorter than 4 inches above the knee.

Slits in dresses must be no greater than 4 inches above the knee.

No immodest bare backs (back of dress can be no lower than the traditional bra line)

No low necklines that reveals visible cleavage. Dresses with plunging necklines are not permitted.

No visible midriffs or cut-outs below the traditional bra line.

No see-through dresses and no see-through sides or bare sides.

Dress shoes only. No athletic shoes, boots or slippers.

No visible body piercings other than the ear lobes.

#### **Boys**

Coat, collared shirt and traditional tie (sport coat and dress pants, suit or tuxedo) are mandatory. Shirts tucked in at all times.

Pants must fit properly and must be worn at an appropriate level to the waist.

Dress shoes and dress socks are required. No athletic shoes.

No ball caps or bandanas

No visible body piercings other than the ear lobes.

Any Bishop Dwenger student who does not meet the dress requirements will be denied admission to the dance. Non-Bishop Dwenger students who do not meet the dress requirements will not be admitted. **Bishop Dwenger students are responsible for informing their dates of the dress guidelines.** 

Non-Bishop Dwenger guests who violate these rules will be subject to having their school IDs confiscated and returned to their home school. All guests should be properly registered through the guest pass request and contract.

If students have any doubt about the appropriateness of their attire, they should ask a school administrator ahead of the event rather than be placed in the embarrassing situation of being turned away at the door.

## **BEHAVIOR**

#### **ILLEGAL SUBSTANCES**

All students will remain tobacco, drug, and alcohol free at all school dances. Students will be randomly checked for illegal, unauthorized or controlled substances prior to entry to the dance area and subjected to a breathalyzer and/or field sobriety test before, during and after the dance. Any student who refuses to comply will be denied entry, removed and parents will be notified.

Any vehicle in the parking lot and drop-off area may be searched at any time. The driver and passengers in the vehicle will be held responsible and given consequences for any unauthorized object or illegal substance in the vehicle.

## DANCING GUIDELINES

No straddling legs.

No front to back grinding.

No inappropriate or suggestive touching.

No overt and/or prolonged public displays of affection.

Lewd dancing will result in a student being asked to leave the event and may make him/her ineligible to attend future school events. Parents will be notified.

Parents of students who have not arrived at the event by 9 p.m. or those who choose to leave prior to 10:30 p.m. will be called to confirm that the parent knows of their child's whereabouts. Under no circumstances may any student or guest leave and return to a dance.
